

GIFTS OF SECURITIES TO ST. MICHAEL'S FOUNDATION

Gifts of securities from non-registered accounts are a cost-effective opportunity to make an investment in the best health care possible at St. Michael's Hospital and Providence Healthcare. By donating appreciated shares, mutual funds, stock options or flow through shares, donors pay no tax on the capital gains, receive a tax receipt for the fair market value of the securities, and reduce their taxes.

MAKING A GIFT OF APPRECIATED SECURITIES - HERE'S AN EXAMPLE:		
	Option 1: Sell shares and donate cash	Option 2: Donate shares directly
Current Value of Shares	\$50,000	\$50,000
Amount Paid for Shares	\$20,000	\$20,000
Capital Gains	\$30,000 ($\$50,000$ current value - $\$20,000$ purchase price)	\$30,000 ($\$50,000$ current value - $\$20,000$ purchase price)
Tax on Capital Gains	\$7,425 ($\$30,000$ capital gains x 50% taxable gains x 49.5% *)	\$0 (no capital gains tax payable on donated shares)
Charitable Tax Receipt for Gift	\$50,000	\$50,000
Tax Credit	\$24,750 ($\$50,000$ donation x 49.5% *)	\$24,750 ($\$50,000$ donation x 49.5%*)
Net Tax Savings From Donation	\$17,325 ($\$24,750$ tax credit - $\$7,425$ tax on capital gains)	\$24,750
Total Tax Savings From Donation	\$17,325 ($\$24,750$ tax credit - $\$7,425$ tax on capital gains)	\$32,175 ($\$24,750$ tax credit + $\$7,425$ in tax on gain not paid)
Net Cost of Gift	\$32,675 ($\$50,000$ gift - $\$17,325$ total tax savings)	\$17,825 ($\$50,000$ gift - $\$32,175$ total tax savings)

*assumes gift made in Ontario at the top marginal tax rate of 49.5% (2015)
